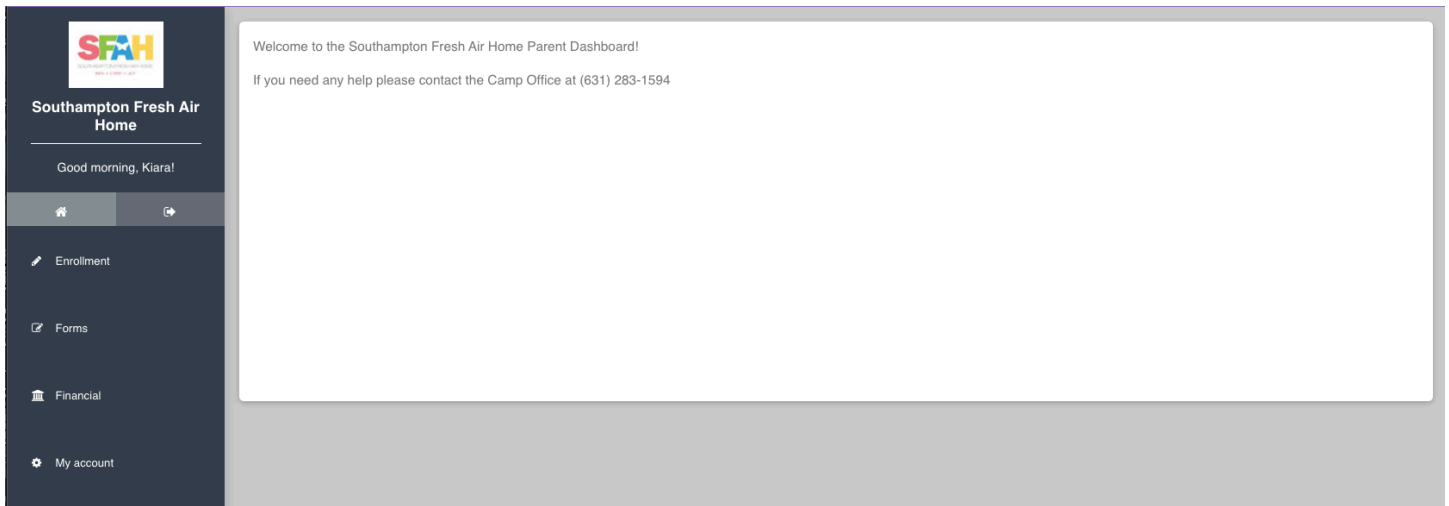


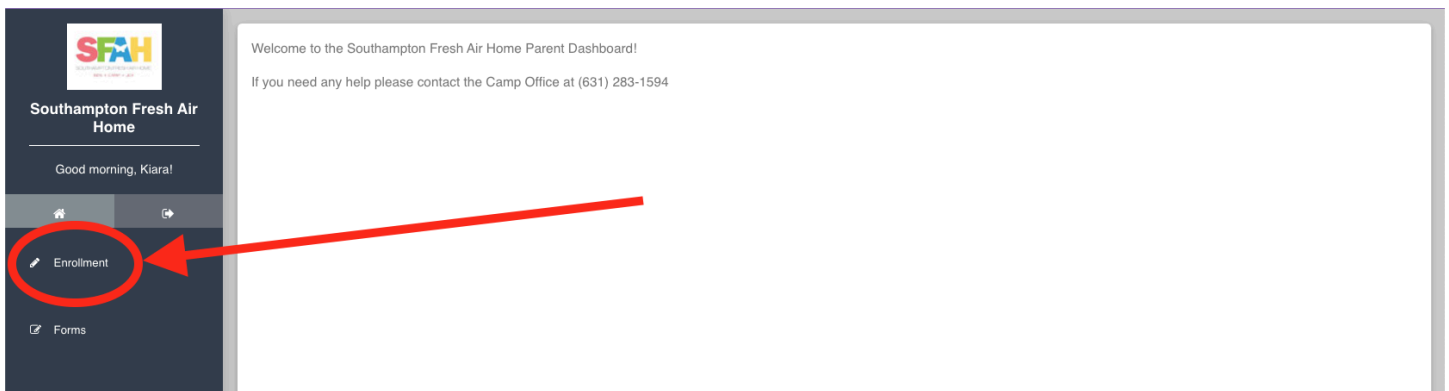
# Full Guide to Completing an online SFAH Summer Camp Application

**Step 1:** In Safari or Chrome, go to: <https://sfah.campmanagement.com/p/campers/>

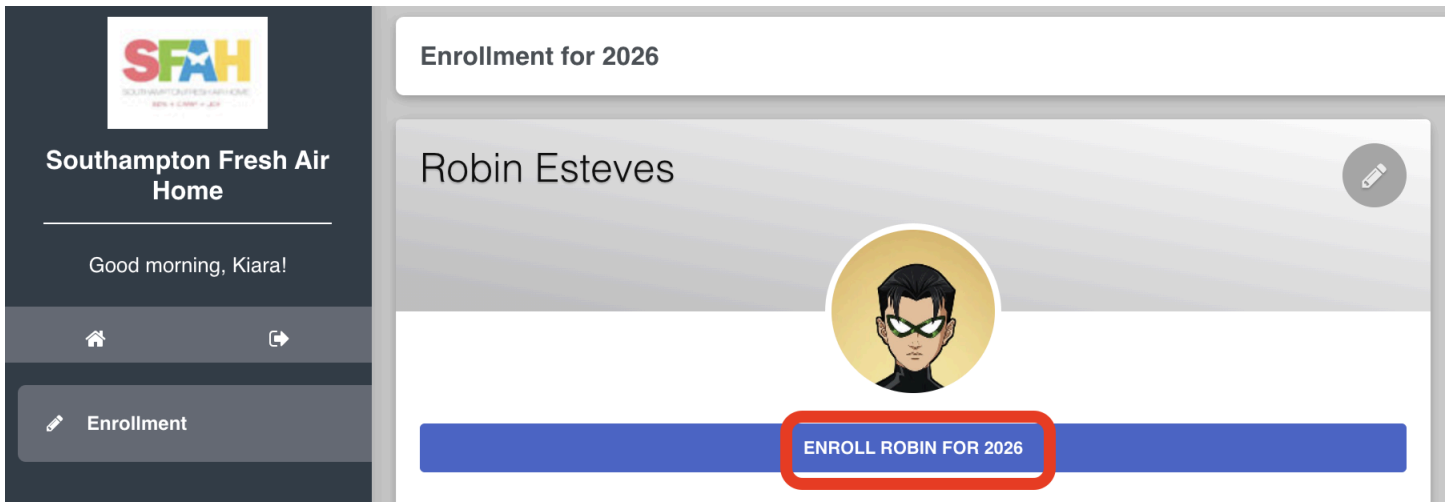
Your main page should look like this -



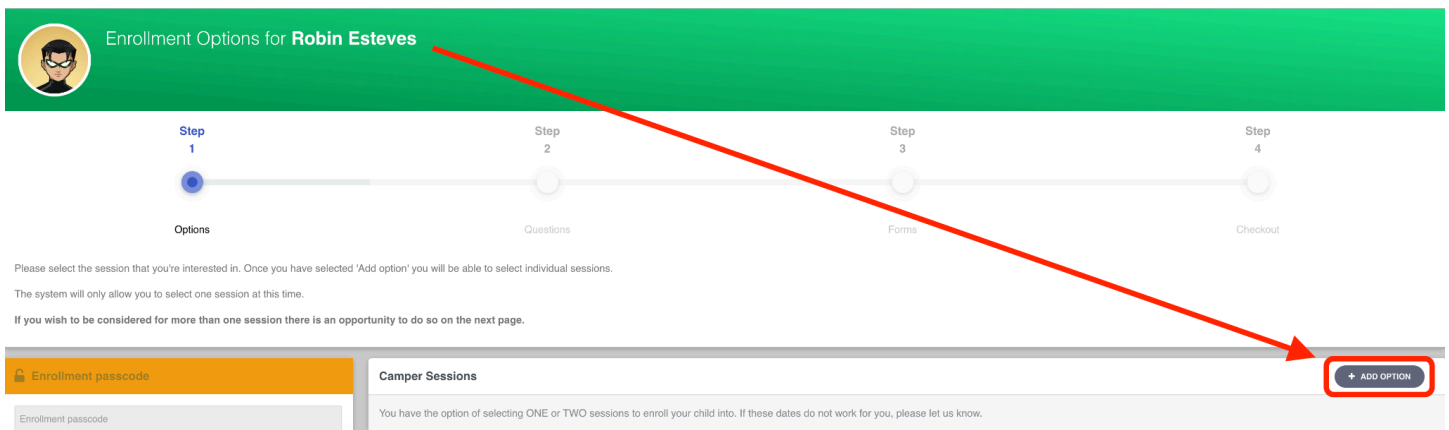
**Step 2:** Click “Enrollment” on the left-hand side



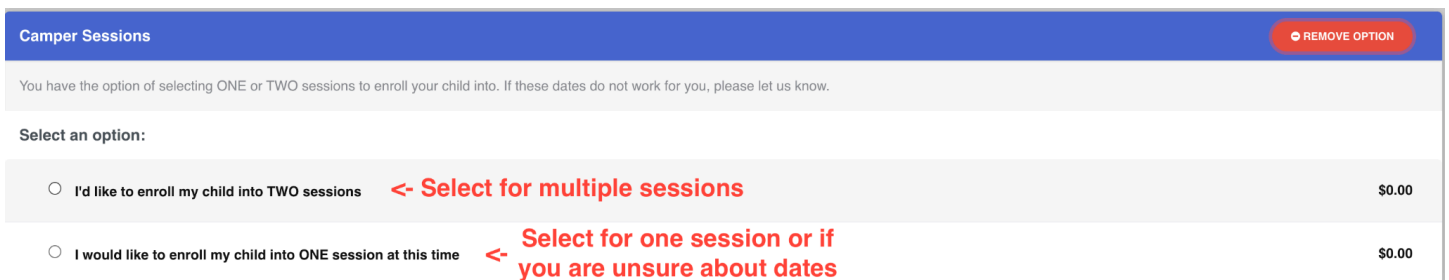
**Step 3:** Once you’ve clicked “Enrollment” you’ll see the campers name and photo. If there is no photo, please add one. Click “Enroll [Your child’s name] for 2026”



**Step 4:** On the right-hand side, click “Add Option” to select your preference of number of sessions for your child(ren).



**Step 5 \*NEW\*:** If you’d like your child(ren) to definitely attend more than one session, select ‘I’d like to enroll my child into TWO sessions.’ If you are unsure about multiple sessions or if your child(ren) has frequent medical treatment. Select your session classification, then click “Save & Continue.”

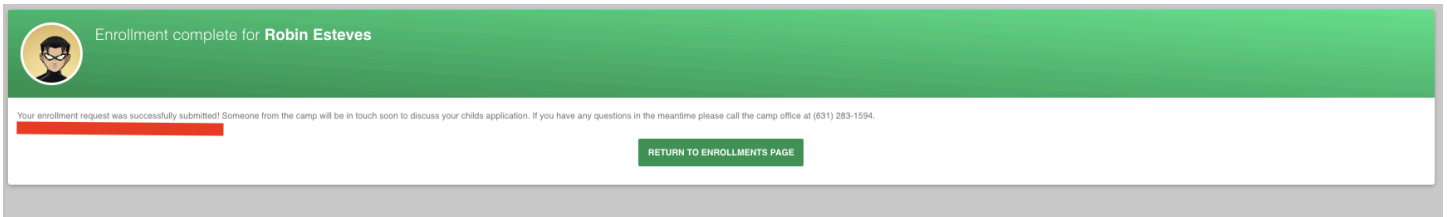
Refund Policy:
